22	Monroe Avenue, Dunmore. Janet, please explain
23	why they should choose you for being on the
24	Planning Commission.
25	MS. BRIER: Hey Guys.

MR. DEMPSEY: Mrs. Brier.

MS. BRIER: How are you? I'm a lifelong Dunmorean, fourth generation, all my brothers and sisters graduated from Dunmore, my mom did, my kids did, my grandparents didn't because they only went to sixth grade.

But you have a history of contributing to the Borough. My grandfather was a Congressman. My aunt and uncle were Councilman and Councilwoman at some point in their lives. And I'm a certified public accountant with a Master's in public health.

So I do bring that piece to it at least the financial piece. And I think I'd do a good job, totally love this town, totally want to give a little bit back. So thanks so much.

MR. MCHALE: Thank you.

MS. SCRIMALLI: Thank you.

MR. DEMPSEY: Thank you.

MR. RUGGIERO: Thank you very much.

MS. BRIER: You're welcome.

MR. RUGGIERO: Council, this is Gary Duncan, 117 Barton Street in the Borough. Mr. Duncan, please tell Council why they should

choose you to be on the Planning Commission.

MR. DUNCAN: Usually I'm up here talking about the Neighborhood Watch Group.

But anyway, Gary Duncan, 117 Barton Street.

You know, I'm married. My wife is Lynne Greco Duncan. We have two daughters Anne and Claire.

And I'm a former full-time faculty member of Misericordia University where I taught kinesiology, neurology, physical disabilities. And that was way back in the 80s and 90s. I spent 43 years in health care. And I went into it for the oldest of cliches. I really did it because I wanted to make a difference in people's lives. And I thought we could make a positive influence in them.

To this day I'm still -- I'm a lecturer at Marywood University. I teach the rehab component for the nursing administrator's course. Chances are there's people in this room that have either been my students or I've been in their home to treat their family members.

My wife and my children and I -- really my wife and I have tried to emphasize the importance of giving back to your

community. And I have a 22-year-old daughter who just graduated from Marywood and so she may be leaving us. And thank God I have one that still may be around for a couple years. But wherever they ultimately wind up -- and I pray -- I think my oldest daughter will be in Dunmore until she passes.

But we've encouraged them to give back to their communities. And I think that we've done that. They have done it as Girl Scouts. We work at food pantries. I'm the former president of the Hibernians. I still continue to be part of an annual food drive at the St. Patrick's Parade.

I've been a rehab director. I had a million dollar budget. And I have a degree in business in addition to being a nurse and an occupational therapist. So I think I know a little bit about budgeting. I won't pretend to have the expertise that a certified public accountant has.

But I certainly know where to look for the answers if I personally don't have them. As I said, I got into health care because I wanted to give back to patients.

I'm a member of the Governors

Council on Ageing. I'm 1 of 11 people. It had to be a unanimous appointment. And we did that with a Republican Senate and Congress. And I'm not and I still got on. We're able to roll out policies and procedures for the geriatric and the handicap residents of 67 counties of Pennsylvania.

So I know how to be a team member.

And I know how to write policy and procedure.

Probably four years and change ago, when Mike

Hayes was on this Council, I came before the

Council at that time and spoke about the need

after having spoken to about 30 or 40 residents

of Dunmore who had expressed various concerns I

came here to talk to you folks and get an

education about former neighborhood watch

groups that existed.

And I think in the four years and change that I started that, you folks have all been a part of it. I think we have grown that in Dunmore. We have police liaisons that have been at every meeting. And I always give Tom Richardson a shoutout because he doesn't miss them.

We have members of Lackawanna County
Probation and Parole who are now a part of it
as well as a representative from the District
Attorney's Office. We've had speakers
including Judge Moyle and others. Dunmore Fire
Department comes down every year. They do a
presentation on fire safety in October for us.

I belong to the Dunmore Historical Society. I would like to think there's not too much in Dunmore that I haven't joined and been a part of. And I've written a grant for \$14,000 this year. And based on -- it may sound like it's not a lot, I could tell you when I was in Harrisburg and on the Council on Aging meetings, I went over looking for more money and they told me they didn't have it.

And by God, the next day in the Scranton Times the report was out that essentially Pennsylvania's budget was in dire straits but we tried. And we at least got a county grant. So I have written grants. I am grateful to Council for opening up these positions.

I'd like to become a member of the Planning Commission because as I said earlier,

it's one more opportunity to give something back to the town that we all live in. I wake up in Dunmore. I go to bed in Dunmore. I love Dunmore. It's that simple.

I like the Planning Commission because I thought it would give me an opportunity to take a look at business growth, community development, look at that from both the long and short term perspective to help potentially in the development of business engines, to review land use and what may be underutilized areas of our Borough.

I'm genuinely, genuinely, optimistic about the future of our town. And I'd like to be a part of that as a member of the Planning Commission. I think everybody that's here tonight -- I know the other folks are back there.

Whoever you people decide to pick, the only thing I would ask of any candidate is this, I've spoken to you before about this. I think it's so important to give back to your community and to be a part of that voluntaryism.

And I hope whoever gets appointed to

the Planning Commission is willing to give it
150 percent of their personal commitment. I
think it's so important to our town. I
probably spoke for five minutes now. I cut it
short. I always remember my five minute time
limit. Is there any questions or -- thanks
everybody.

MR. GROCHOWSKI: I just have some -these are just reference materials. This is
actually information that I sent along. This
was stuff I sent via e-mail and some additional
information that I just want to briefly share.

What I just distributed was when I initially expressed my interest in the position some of the information I sent along was the original e-mail with my interest which I'll cover tonight along with some of my professional and personal experience.

And I actually just gave you a copy of current clients that I work with just to

give you a sense of the current world I'm in.

So my name is Joe Grochowski. I live at 1711

Adams Avenue. I was born and raised in

Dunmore, born here in 1975, graduated from

Scranton Prep.

I left Dunmore to go to Penn State
University in 1994. I graduated from Penn
State in 1998 with a BS in psychology. After
Penn State I decided to continue my graduate
studies at the University of Chicago. I
received my Master's of Arts in Social
Sciences.

Right after the University of

Chicago I was employed at -- I got a job offer

at the company called SPSS which is an

analytical software company now owned by IBM

doing analytical analysis for the government

and other agencies wanting to understand

correlations and very complex analysis.

I worked there for a year and then moved to New York City. I work at the Research World which is a think tank for chief information officers from the world's largest companies in the world, had the pleasure of interviewing and dealing with technology

related issues on how to plan, build their development plants for large companies like GM, Bowing, Lockheed Martin, worked with Bill Gates. We've interviewed Bill gates.

I had a lot of experience working with C level executives from the Fortune 500 at the Research Board. I'm -- then I went onto I started working virtually. I worked for a company called the Concours Group which is a managing and consulting firm.

I was promoted ultimately to director of all their leadership development programs for senior level HR executes again from the Fortune 500 companies.

Today I -- for over seven years I worked for the RBL Group which it stands for the Results Based Leadership Group. We are the trusted advisors to the world's largest companies. You have a list of those companies there. Those are my clients that I advise and consult on related to the town, the development of their chief information officers and senior teams, how to compete and win in the marketplace.

I first made a deal with companies

like Ikea, Goldman Sachs, MGM, Coca-Cola.

Collectively the people I work with probably employ over 2 million people. HR budgets are probably larger than our state budgets.

And so I had the pleasure actually of working with large companies across many industries pharmaceutical and so forth.

Fifteen years doing management consulting, work with the C level people, chief information officers, CEOs, academics. I kind of built to that intersections of business and academia.

I do a lot of research, writing, analyzing, preparing reports. I've published over 250 reports for businesses on planning and developing and around technology and HR. So that's what you have in front of you. Also personally I moved back to the area in September of 2014. I bought a home at 1711.

And it has been a thrill to be back to the community. And that's why I am here today. My sole interest in the planning position is serving the wonderful community of Dunmore and providing planning advice and guidance to Council as they see fit in terms of land use, proper use of our land. How do we

grow and develop as a community responsibly, what are our current needs, what are our future needs, how do we address those gaps. I have a lot of skills collaborating with other people in business and governments.

My sole purpose is kind of a civic issue where you could kind of if you want to help, you have to do something about it. So and finally I -- just on a personal front I am married. My wife Nicole is -- they're over at a T-ball game right there right now. My son Nate is playing. He's 8 years old. He's actually a fraternal twin. My son died at 16 months of age.

That's why you'll see the

Maximmillian Fund on my resume. We started a

nonprofit in honor of my son to serve the

community. We actually gave a grant to the

YMCA last year for the education and

development of children.

And my youngest son Jacob also plays. I'm the coach at Dunmore T-ball. I'm a certified baseball umpire. I'm on the Scranton Alumni Board of Governors. And I coach my kids. I love my community. And I would love

to serve and plan and help in whatever way I 1 So thank you Council for your time and 2 3 attention. And I hope you get a chance to 4 review the materials. And if you have 5 questions, please let me know. MR. MCHALE: Thanks, Joe. 6 MR. HALLINAN: Do you want to run 7 8 the Farmer's Market? 9 MR. GROCHOWSKI: Great idea. Thanks. 10 11 MR. HALLINAN: Thank you. MR. RUGGIERO: 12 Council, Jerry 13 Michaels, 317 North Apple Street. 14 Michael's, please describe yourself to Council and why they should choose you to be on the 15 16 Planning Commission. MR. MICHAELS: Good evening, 17 18 My name is Jerry Michaels. I'm here 19 tonight to submit my name for your 20 consideration to renew my seat on the Dunmore 21 Planning Commission. 22 I have been a member of the Planning 23 Commission for eight plus years. And I have 24 been acting as Secretary. I'm a lifelong 25 resident of Dunmore. I'm a graduate of

University of Scranton with a degree in accounting, licensed real estate agent with my license in escrow at present. And I'm a retired store supervisor for a large chain store in the area. That's all. Is there any questions?

MR. DEMPSEY: No, sir. Thank you.

MR. MCHALE: Thank you.

MS. SCRIMALLI: Thank you.

MR. RUGGIERO: This is Roseann
Zubrickas, 1121 Prescott Avenue in Dunmore.
Roseann, please describe yourself to Council
and why they should choose you to be on the
Planning Commission.

MS. ZUBRICKAS: My name is Roseann Naro Zubrickas. And I have been an alternate member of the Dunmore Planning Commission since November, 2011, shortly after the death of my dad, Salvatore J. Naro who was a member of the commission.

As an alternate, I have only missed one meeting since 2011, whether my vote counted or not. I have been in the Dunmore community for very close to 60 years. I have raised my children in this community.

They were both schooled in this community and still both live in this community. My daughter lives at home and is a Pennsylvania State Policeman. And my son and daughter own a home on Hill Street. I always tease him that he's a Hilly now and I am still a Gully. I know I'm dating myself for sure there.

I feel I would be a good candidate because I have proven myself to be loyal and committed to the commission and my main concern is Dunmore. I hope to have grandchildren some day. And I want them to be healthy and happy and safe. I want them to be proud to say they are from Dunmore, Pennsylvania like I have been proud my whole life.

I have everything I need in this life and I am very blessed. I don't want anything from anybody. And I don't think need anything from anybody. I feel I would be an asset to the Planning Commission of the Borough of Dunmore. And I thank you for your time and your vote.

MR. MCHALE: Thank you.

MS. SCRIMALLI: Thank you.

MR. DEMPSEY: Thank you.

MR. RUGGIERO: Council, this is
Katherine Oven, 1630 Madison Avenue in Dunmore.
Katherine, describe yourself to Council and why
they should choose you to be on the Planning
Commission.

MS. OVEN: My name is Katherine Oven as Vince said -- Vito said, I'm sorry. I was looking at Vince. I live in Dunmore. I lived here about 18 years. And when I heard there was some opportunities with the planning, I decided to put my name in.

I'd like to get more involved in contributing to the Borough. I have children who live here. And I have a vested interest. And I think there's lot to be done as far as preserving the natural resources in the area, protecting the land.

And I would love the opportunity to work with the zoning and with the Council and with our new Mayor trying to make Dunmore a beautiful place to live and for future generations to move back to. Thank you.

MR. MCHALE: Thank you.

1 MR. HALLINAN: Thank you. MR. AMICO: Thank you. 2 3 MS. SCRIMALLI: Thank you. 4 MR. RUGGIERO: Council. Tom Pichiarella, 142 Potter Street in Dunmore. 5 MR. PICHIARELLA: Hi everybody. 6 7 Vito told you who I am. I have been on the 8 Planning Commission for about seven years now. 9 I have a business in Dunmore. I'm also an 10 engineer. I want to be on the Planning 11 Commission so I could help the Borough grow in 12 a smart and sensible in accordance with the 13 ordinances. Is there any questions? 14 MR. MCHALE: Tom, how long have you served on the Planning Commission? 15 16 MR. PICHIARELLA: Seven years. 17 MR. HALLINAN: Seven years. 18 MR. MCHALE: You said seven years. 19 I apologize. I didn't hear him. Thank you, 20 Bud. 21 MR. HALLINAN: Thanks, Tom. 22 MS. SCRIMALLI: Thank you, Tom. 23 MR. RUGGIERO: Council, Al 24 Senofonte, 712 East Drinker Street in Dunmore. 25 Mr. Senofonte, describe yourself to Council and

why they should choose you to be on the 1 Planning Commission. 2 3 MR. SENOFONTE: My name is Al Senofonte. And I'm a Dunmorean. I have been 4 5 on the Planning for a long time. I have been the chairman for several years. All I could 6 say is I don't believe you've had any grief 7 8 come back to Council over the way we've 9 performed. We've been consistent with all of 10 our decisions. We have a good board. 11 I believe after tonight we are going to lose some of the members because they didn't 12 13 reapply. And if you have any questions, I 14 would be more than happy to answer them. MR. DEMPSEY: No questions. 15 16 MR. MCHALE: Nothing, Mr. Senofonte. 17 MR. SENOFONTE: I was expecting some 18 questions. I prepped all day for this. 19 MR. MCHALE: How about your 20 background, Mr. Senofonte, your business 21 interests, things like that? 22 MR. SENOFONTE: Business interests, 23 we have a currier service. We have a tree 24 service. We have a restaurant up in Dunmore. 25 We do a lot of volunteer work. I have always

done volunteer work for Dunmore, whether it be helping the veteran's paint flagpoles in the cemetery, whether it be our equipment for Jog For Jude.

Anyone needs anything, they ask us.

You know, we are always there. We don't have a problem with that. We're more than happy to help out. All my kids -- most of my kids live in Dunmore. They do a variety of sports and activities in Dunmore. I have a good family.

And once again as far as Planning, I look at my -- I look at our Planning Commission as your cabinet. If we perform well, you guys don't get any grief. If we don't perform well, people will come to you. All I could say is since I've been chairman, all of our decisions have been consistent and fair.

And I feel good about that. And I could go to bed every night and sleep well. In the past I've heard it was a little different, you know, people were getting phone calls and whatnot. This is going back 20 years. That has all changed. Fortunately I have never received a phone call from any of you guys or

girls on Council as to weigh one thing one way or the other. And I appreciate that. You let us make our our decision and we have been fair and consistent.

MR. MCHALE: Thank you,

Mr. Senofonte. We appreciate it.

MR. DEMPSEY: Appreciate it.

MR. HALLINAN: Thank you.

MR. RUGGIERO: Council, this is
Elizabeth Zangardi, 120 Homestead Street in the
Borough. Elizabeth, describe yourself to
Council and why they should choose you to be on
the Planning Commission.

MS. ZANGARDI: I was born and raised in Dunmore. I -- for me, I feel everybody applying the ultimate goal for all of us is what's best for Dunmore -- actually the Council, Planning, and so on. So for me it's a privilege.

I -- it's a challenge for me. I know what's going on. I'm active in my community. And feel I vote and study for what I believe is best for the community. I do research when I get the proposed -- proposals.

I study the maps. I go out and I look to see what changes the people want. I go to the addresses for what is being proposed. And I study it. And so I feel -- I've been on it for I think -- I'm not really that good with years, but I think it's eight or nine years.

I'm faithful to it. I'm loyal to it. I show up. I show up to the meetings.

And I vote for what's best for Dunmore, I believe. That's it.

MR. MCHALE: Thank you very much.

MR. HALLINAN: Thank you.

MS. SCRIMALLI: Thank you.

MR. RUGGIERO: Council, that concludes all the candidates for the Planning Commission.

ATTY. CUMMINGS: Next item prior to the regular meeting is a presentation from Michael Cummings regarding health care plan and cost reduction.

MR. CUMMINGS: Good evening,

Council. As your Solicitor mentioned, my name
is Michael Cummings from Cummings Insurance.

And I appreciate the opportunity to be in front
of you this evening to provide an update on how

the Borough has performed over the past little more than two years in your PMHIC Program.

So just a little background,

April -- I'm sorry, in the third and fourth
quarter in 2014, I engaged with the Borough and
provided analysis to examine your medical
benefits that the Borough has for its employees
and to determine if it was prudent or not to
move from your fully insurance arrangement of
Blue Cross of NEPA into an self funded
arrangement or rather anything other than what
you were doing.

For years Council would -- I'm sorry, the Borough would receive some pretty big increases from the carrier Blue Cross of NEPA and there was really no other recourse. So we did an analysis over many months. And the Borough of Dunmore in April of 2015 joined the PMHIC Program. PMHIC is an acronym that stands for Pennsylvania Municipal Health Insurance Cooperative.

It's a self funded program. And there is approximately 250 other entities like the borough, a township, a borough, a small city across the Commonwealth that are part of

this consortium. You have done very well in this arrangement since joining. So you joined April of 2015.

It was a short plan year because the Borough runs on a 1/1 to 1/1 year for its plan. So you joined in the middle of the year, short plan year. But for 2015, so your April through December 31st, you received a return of \$190,511. Those are monies that weren't spent on claims that were given back to you in 2016.

You continued very positive performance in 2016 as well. So you had a full year in 2016. And this year you should have received a 75 percent of your surplus already. You get the next 25 percent in the fall. But you will receive for your performance in 2016, \$216,910.

So for two years -- your first two years in the program, you received a total surplus return of \$407,421. So during that time period you paid approximately 2 million dollars in I guess you would call premiums. Technically that's not the term in the arrangement that you're in.

But you paid out about 2 million and

you received back or will receive back aggregate \$407,000. So that is just a complete turnaround from previously of continuous increases of really nothing else to do and just taking it from the carrier.

The best thing about this I think is that you maintain the integrity of the program and your benefit. Your employees still are able to keep the same level of benefit although Highmark required BC NEPA they're still with Blue so they walk around with Blue Cross cards. They went to the same doctors and hospitals, etc.

You maintain the integrity of the benefit and you receive \$407,000 back of monies that, you know, would have just gone to a carrier in terms of keeping their profit. But the money went back to you because it wasn't spent on claim dollars. So I'm very appreciative for the opportunity to work with the Borough.

As a resident of the Borough of Dunmore, I'm happy that the Borough is acting very prudently and saving money on a benefit that costs a lot of money. So thank you very

1 much.

MR. DEMPSEY: No, Mike. I just want to say you guys do an excellent job down there. You and your brother and your dad provide us with absolutely excellent service. I've never heard a complaint. You guys are always here, answer your phones, answer your cell phones no matter what time of day it is. So I appreciate that.

Any questions?

MR. CUMMINGS: Thank you very much.

MR. MCHALE: Michael, real quick just to backtrack into prior to you guys taking this plan and running with it, our costs were averaging around a million dollars. And in the initial year that I don't even think you're including, we were able to cut our as you say premium the first year several hundred thousand dollars to get into the program.

So we saw an initial savings. And then obviously the 200 -- we haven't seen an increase over the -- of what we contribute every year the last couple years which is massively important. On top of that, we're getting these premiums returned to us. So I think it's something that also has to be

pointed out the premiums haven't gone up. You know, like as you alluded to we were getting 20, 30 percent. Mr. Ruggiero -- he dealt with it prior to you guys coming in. So to that point again, thank you for that.

MR. CUMMINGS: I hope you continue to perform well. That's not a guarantee. You know, when you're -- you look over a seven year period you're going to have two really good years. You're going to have some mediocre years. You're going to have the bad year.

It's going to happen. But, you know, use the monies that are returned, build up a reserve. And when that bad year comes you're ready to fund that. But it will turn around again. It always comes back to the mean.

You're doing a very prudent thing by taking more of -- you're taking it into your hands and you're not just letting a carrier just give you increases every year and not explain why that's happening. Thank you very much.

MR. MCHALE: Thank you.

MS. SCRIMALLI: Thank you.

night.

MR. HALLINAN: Thank you. Good

ATTY. CUMMINGS: Prior to public comment which is agenda item number four, there will be an addition to the agenda. It will be scheduled at 9.1. And it will follow number nine. That will deal with the SSA sale review.

At a prior meeting Council had voted to request that the Scranton Sewer Authority request the Auditor General to review certain portions and particulars of the transaction sale as set from SSA to Pennsylvania American Water.

Mr. Dempsey made a very specific motion at the Scranton Sewer Authority as Dunmore's representative that did not pass with the majority of the vote. So it fell to the wayside. So the next step that has been discussed is to have the Attorney Generals's Office review the particulars of sale and compliance with the SSA sale agreement. So that will be 9.1. And Mr. Dempsey will handle that. Number four public comment on agenda --

MR. DEMPSEY: And, Tom, can we go there, can we add a 9.2?

ATTY. CUMMINGS: 1 Sure. 2 MR. DEMPSEY: And that would be 3 motion to ask or send a letter to the SSA that they reconsider their stance on allowing the 4 Auditor General to come in and review the sale. 5 ATTY. CUMMINGS: That letter would 6 be from Council? 7 8 MR. DEMPSEY: Yes. 9 ATTY. CUMMINGS: Okay. Sure. That 10 will be 9.2. And now it is number four, public 11 comment on agenda items. 12 MR. MCHALE: Anybody like to address 13 Council tonight, please come up and state your 14 name for the record? Name and address for the record, please. Anybody? 15 16 (No response.) 17 MR. MCHALE: Oh, I'm sorry, I 18 apologize. It's been a long day -- on agenda 19 items only, I apologize. Tom, seeing none. 20 ATTY. CUMMINGS: Seeing none, number 21 five is a motion to approve the minutes. 22 MR. DEMPSEY: I'll make that motion. 23 MR. VERRASTRO: Second. 24 MR. MCHALE: I have a motion and a 25 second. On the question.

And it's paid off to the tune of \$407,000. So it's something we're very proud of. The banking is the same way. We've done a ton of stuff there. Our pensions are in line. So I'm not going to -- I talked about that a lot. So I won't bore you with that.

The one thing that I did want to go into that is -- was mentioned in the Scranton Times I believe last Saturday is the Borough's acquisition of the Schautz property, something that we are massively happy about.

To give the details that were not given in the Times, we paid zero for it. It was donated to us from the Schautz Foundation. I'm pretty proud of that because, you know, I think everybody knew that over the past 10, 15 years, it was going to be sold for 1.5, 2 million dollars.

He saw what the possibilities and wanted to return it to the Borough -- the youth of the Borough. He sees the need. So publically we're going to do a proclamation or something to honor Walter Schautz who lives right behind Mr. Grochowski actually.

He's a very great man and his

foundation does a lot of very good work that don't like a lot of credit for. So we won't embarrass him as he says. But he's a very quiet man. So we're going to honor him in a good way. The plans for that are wide open.

Council has yet to meet on that. A couple of us have met with a lot of our representatives to try to get some grant money. But the overall thought process here is the town, the kids especially need fields. These fields have turned out phenomenally.

Vince is very much involved with the softball, absolutely great. I think our soccer program is really, really in need of stuff like that. And our older kids on the baseball end, Mr. Ruggiero works with a lot.

Although they could use the school, sometimes it's not always available to them. It doesn't have lights as Schautz always did. Schautz as I was quoted was our Yankee Stadium when I grew up. So I think it's our hope -- it's our dream that we're going to return it to the place where everybody wants to be again.

And when you drive through Dunmore and you see the lights on at Schautz, you know

something good is going on up there from, you know, the Scranton Red Socks at Schautz
Stadium. The Schautz Teener League we've all played there, either softball or baseball or all of the above.

The playground with the asphalt is still up there. It's still standing. The monkey bars are all there. The merry-go-round still works. It's all up there. It's not in good shape but we are going to do something about it.

Just to give you guys an idea, we had an architect give a rendering of what it could be. It's up here but you could see with the possibility of doing a soccer, baseball, and putting in a new playground and make it a showpiece that it could be. So something we're very proud of and we're going to move forward on in short term.

I'll leave that for everybody to take a look at after the meeting. This is another one that it gives an aerial view of what the property looks like. We own the entire parking lot now, the entire property which is much bigger than we thought.

If you could picture where the playground is in the back, squared off, there's a lot of land that has a ton of trees on that will be knocked down and made green space as well. So thank you again to Walter Schautz and the Schautz Foundation for their commitment to us and seeing the vision that hopefully we can take this back to a field where all the kids both young and old can play for a long, long time.

So that's desperately needed in the Borough. So we're proud to present that to you guys tonight. I think that's all as I'm losing my voice. I'll pass it along to Vince. Do you want to start us off tonight?

MR. AMICO: Yeah, I just want to remind everybody that this Saturday and next Saturday, June 17th and the 24th at the Community Center from nine until noon will be our Electronic Recycling Program in coordination with the county's program.

aside a space for one stand where it will be for anybody in the community where a non profit say Boy Scouts, Girl Scouts, you know, Little League, Dunmore Oilers where they could come in, set up for the day.

They'll make plans with Vito at the Borough Building, reserve that day and try to make some money for their organization rather than standing out in the street and get threatened by cars and stuff.

Also I want to thank Mike for -nobody knows, this was at least a two year
process that he's gone through to try to get
this together and the work that Michael went
through and he doesn't like taking accolades,
but it's been drawn out -- if you knew, the
University tried to get this, Lackawanna
College tried to get it.

He's turned them down and Michael made this dream come through for the Borough. What we could do with it, you know, I hope it becomes a showcase in Northeast PA. And I want to thank you, Mike, for everything you have done that on that. And I'm sure everybody else in the town will too.

And one more thing, Ron, God bless your community and everything that you guys just went through up there. My prayers are with you and I'm sure and everybody on Council. It's a horrible thing up there. God bless your town. Thank you.

MR. MCHALE: Thanks, Tom. Well said by the way. He speaks for all us. That's well said. Michael.

MR. DEMPSEY: Yeah, I just want to piggyback on your comments, Michael, what we have been able to accomplish, I have been three and a half years. I know you're double that. Timmy and Carol probably double that or at least equal to that.

This new stadium is unbelievable. I have two young kids. I have a seven year old and a four year old that will be able to enjoy that for however many years. In addition to that, we have -- and this is just a few items; added six additional police officers, a million dollar fire truck, a new fire station, LED lights throughout the entire town.

We acquired Schautz Stadium. We added a Canine Unit to the Borough.

Mr. Cummings has explained, you know, we scrutinize every contract and scrutinize all of the insurances that we have. Again, that is another \$400,000 that we didn't have -- the health insurance.

We have brand new police cars. We have brand new fire trucks. This was all done in the three and half years I know that I was here and you guys have done a ton more before that.

I know I'm forgetting things. But we've done this without raising taxes. And we've done it within your budget. So, you know, we're pretty proud of that. I can't wait for this field.
