And 10 they responded and it saved the boy. 11 Now four houses up there's an alleyway right across if you are familiar with 12 13 Tommy Golden's old funeral home, two boys come 14 down on bicycles. And the one boy leading was racing. And I'm familiar there. And I was 15 16 going about 10 miles an hour. I hit the 17 brakes, blew the horn. 18 And it took that kid approximately 19 40 feet to stop. By the time he applied the 20 brakes, there was a car parked that I was 21 further down but if it was anybody else because 22 I live on that street and I see people in the 23 Sixth Ward coming up there 20, 30 miles an 24 hour. 25 They are racing to get kids to

1	school and now school is out. And it's time to
2	put the brakes on and pay attention to the
3	children. We want to save lives. And they may
4	be your children.
5	And there is a state law that kids
6	on a bicycle under 12 years old will have a
7	helmet. And there's a lot of parents in
8	Dunmore that didn't go out and buy the kids a
9	helmet and they are out on the street where
10	they could be seriously injured.
11	And if it wasn't for the Borough and
12	Mr. Judge getting that stop sign, maybe I would
13	be going 20 miles an hour and strike that
14	child. And how he stopped is he hit the curb
15	in front of Tommy's. And I said, oh my God to
16	my wife that if he goes off that bike he's
17	going to have a fractured skull. No helmet.
18	And Joe Finnerty lost a child maybe what, 15,
19	20 years ago fell off the bike, fractured
20	skull, died.

22	people could come to this Council meeting and
23	claim, oh, we have stop signs every so many
24	blocks. They have them because people don't
25	obey the speed limit. You're out there and

At the last meeting I informed 3 Council about illegal conversions of single 4 family homes into multiunit apartment buildings 5 being allowed by zoning in a restricted single family zoned neighborhood as designated by 6 7 Dunmore's own zoning map. 8 The Zoning Code Enforcement Officer 9 has yet to provide me with requested proof of 10 legality and variances for these properties. 11 Logically if, in fact, required documentation 12 does exist, it would have been presented to me 13 by now. 14 I have been requesting this information since July of 2013. Pennsylvania 15 16 open records laws and Pennsylvania Municipality 17 Codes have been broken by Dunmore's Code 18 Enforcement Officer. You'll find that 19 information in these highlighted areas within 20 our ordinances that are posted online for 21 public record. 22 Serious issues, detrimental to our 23 health and welfare have since began. Ιn 24 addition to the current rat problem, these 25 three-unit rental buildings have been allowed

1	to be connected by the Borough to a small sewer
2	branch line originally designated to just a few
3	single family homes within my neighborhood.
4	Overwhelming of the sewer branch
5	line is a health hazard. By allowing all of
6	this to continue, the Borough can be held
7	responsible for placing our health and safety
8	in jeopardy, decrease our property values and
9	our right to quiet enjoyment of our homes.
10	Our once beautiful sought after
11	neighborhood now has abandon property and
12	dwellings in deplorable condition due to them
13	being nothing more than money making rental
14	businesses.
15	Absentee landlords and their tenants
16	lack the pride in your home and neighborhood
17	mentality that Madison Avenue homeowners have
18	always lived by. Dunmore is slowly losing its
19	sense of community by all of these factors. We
20	should not as taxpayers have to plead for your
21	service and correction of this matter.
22	The ordinances are clearly written,
23	recorded, and posted online with confirmation
24	with no amendments for our block. I checked
25	with Mr. Lorince and he told me there are no

1	amendments for the 1700 block of Madison
2	Avenue.
3	Years of nonenforcement of our
4	municipality's ordinances is visible within our
5	neighborhood and many others. Mr. Lorince has
6	refused to act or perform his duty as required
7	by law. The Borough's officials must correct
8	the situation caused by a salary employee that
9	Dunmore Council had hired for these duties.
10	And someone had asked me then where
11	my petition was last time if it was such a big
12	deal. So here's a petition signed by 30 other
13	homeowners in the 1700 block of Madison Avenue.
14	I have proof of the decrease of property values
15	in our block alone.
16	I have a list of properties in
17	Dunmore that are listed and online on
18	multi-list realty for over a year. And it
19	shows a decrease in values in those also. But
20	I contacted the Sewer Authority as far as the
21	sewer line goes in my statement. That came
22	from the Sewer Authority.
23	As far as rats in sewers, rats are
24	in all sewers. They only live and choose to go
25	to a neighborhood where they have access to

1	nesting and they have available food source.
2	So the last time and since 2013 I keep
3	telling everyone about garbage. There's
4	transient tenants or six monthers. Six to nine
5	months they are in and out.
6	They don't own garbage cans so the
7	garbage is left on their back porches, on the
8	sides of houses, and then out on the street all
9	night. So the rats definitely have food
10	source.
11	What I'd like to know is, you know,
12	I provided more than enough information. These
13	are ordinances that are for the public to read,
14	public record posted on Dunmore Borough dot
15	org. I'm showing you the violations. And I
16	got one line from Joe Lorince and one line from
17	anyone that spoke to Joe Lorince. And that is
18	they are all legal.
19	But I have yet to get any kind of
20	documentation that would stop me to continue
21	going on this. And through this and through
22	going to people's houses, there's a lot more
23	people. You're going to get North Webster
24	Avenue people here. You're going to get Monroe
25	Avenue people here.

It's not to be there. Two units can be there but not 6 7 three. 8 MR. HALLINAN: And I'm not going to 9 argue with you about this. I'm not schooled in 10 it. But I will tell you this, we're going to 11 sit down Wednesday. We're going to present 12 your side. We'll hear his side. And then we're just going to move forward to the 13 14 attorneys or whoever we have to move with. 15 But it will be straightened out. 16 And you're absolutely correct. We don't want 17 to lose neighborhoods to this kind of activity. This is how it starts. And this is what -- how 18 19 you lose neighborhoods and communities.
